To apply for exams:

- <u>Online</u>: Go to <u>https://madison-portal.mycivilservice.com/</u>. A \$15.00 application fee \*plus \$1.00 surcharge is required for credit or debit card payments.
- <u>By Mail</u>: Applications can be downloaded from the Personnel Department's website at: <u>https://www.madisoncounty.ny.gov/301/Personnel-Forms</u>. Must include a \$15.00 **money order** made payable to *Madison County Treasurer*. Cash or checks are not accepted.
- Applications and <u>non-refundable</u> payment must be received or postmarked by the application deadline. Disapprovals will <u>not</u> result in a refund. Carefully compare your qualifications against the minimum qualifications listed on the announce-ment and apply for only those examinations for which you clearly meet the required qualifications.
- If you are a Madison County employee and are represented by the CSEA White Collar Unit, you are not required to submit a processing fee under the current negotiated agreement.

SALARY: \$33.95/hour (2021 Minimum Hire Rate)

**VACANCIES:** The eligible lists established as a result of this examination will be used to fill present and future vacancies as they occur in the Madison County Mental Health Department.

<u>MULTIPLE EXAMINATIONS SCHEDULED FOR THE SAME DAY</u>: If you have applied to take a written test announced by either one or several local jurisdictions (county, town, city) scheduled to be held on the same test date as this written test, you must notify each of the local jurisdictions no later than two weeks before the test date, so they can make arrangements for taking all tests at one test site. All examinations for positions in State government will be held at a State examination center.

**DISTINGUISHING FEATURES OF THE CLASS:** This position exists in the County Mental Health Clinic and involves responsibility to perform professional social work at an advanced level in the process of helping individuals with social, emotional and related difficulties associated with their mental illness or disability. Since the employee is expected to function with a high degree of clinical independence and judgment, the incumbent assumes a leadership role in overseeing assessments, diagnoses and treatment as well as provision of consultation and educational activities to staff members of the mental health program and personnel of various other county agencies. This position differs from that of Staff Social Worker because of the more difficult level of professional involvement with clients and the supervision of subordinate clinical staff members. Clinical supervision is exercised over the work of a small number of Staff Social Workers. The incumbent does related work as required.

<u>MINIMUM QUALIFICATIONS</u>: Limited to employees with at least one (1) year of permanent competitive class status in the title of Staff Social Worker who also meet the following <u>Open Competitive</u> qualifications immediately preceding the date of the examination. EITHER:

- (A) Possession of a New York State license to practice as a Licensed Clinical Social Worker (LCSW) and current registration, issued by the New York State Education Department at time of application AND one (1) year of fulltime paid social work clinical experience, or its part-time equivalent, in a clinical social work setting\*; all of which must have been post-Master's Degree (MSW) experience; OR
- (B) Possession of a New York State license to practice as a Licensed Master Social Worker (LMSW) and current registration, issued by the New York State Education Department at time of application AND three (3) years of full-time paid social work clinical experience, or its part-time equivalent, in a clinical social work setting\*; all of which must have been post-Master's Degree (MSW) experience.

NOTE: License and registration must remain current throughout appointment.

<u>SPECIAL REQUIREMENT FOR APPOINTMENT</u>: The minimum qualifications for this position are mandated under Article 154 of New York State Education Law.

<u>NOTE</u>: \*Clinical Social Work Setting is defined as any facility/agency in which individual, family and group treatment is provided directly to clients who are experiencing emotional difficulties, and further, that supervision is provided by an approved clinical professional (licensed clinical social worker, psychiatrist or licensed psychologist).

**Seniority Points** will be added to the written test score of candidates who pass the written test in accordance with County policy. Rating is based on the length of continuous permanent classified service. A copy of the seniority policy is available from the Madison County Personnel/Civil Service Department or a copy is posted on the Madison County Personnel Department's intranet page.

**<u>SUBJECTS OF EXAMINATION</u>**: A written test designed to evaluate knowledge, skills, and/or abilities in the following areas:

**Preparing Written Material:** These questions test for the ability to present information clearly and accurately, and to organize paragraphs logically and comprehensibly. For some questions, you will be given information in two or three sentences followed by four restatements of the information. You must then choose the best version. For other questions, you will be given paragraphs with their sentences out of order. You must then choose, from four suggestions, the best order for the sentences.

**Developing & Implementing Treatment in a Social Work Program:** These questions test for knowledge, understanding, and ability to apply social work concepts, theories, standards, principles, and practices in various settings. Questions may cover such topics as assessment, development, implementation, monitoring and evaluation of treatment for individuals and families; coordination of services; advocacy and counseling for individuals and families of all backgrounds; and crisis intervention.

<u>Working with Individuals to Promote Mental Health</u>: These questions test for knowledge of characteristics, causes and treatment methods associated with working with individuals who may have mental, developmental, physical, social, and substance abuse disorders and/or disabilities. Questions cover such topics as establishing, maintaining and terminating client relationships; recognizing, interpreting, and responding to individual and group behaviors, as well as crisis situations; and facilitating access to essential services such as financial, housing, medical, educational, legal, vocational, and recreational.

**Interviewing:** These questions test for knowledge of the principles and practices employed in obtaining information from individuals through structured conversations. These questions require you to apply the principles, practices, and techniques of effective interviewing to hypothetical interviewing situations. Included are questions that present a problem arising from an interviewing situation, and you must choose the most appropriate course of action to take.

Unless otherwise notified, **candidates are permitted to use quiet, hand-held, solar or battery powered calculators.** Cell phones, devices that may be connected to a computer, and devices with typewriter keyboards, "Spell Checkers", "Personal Digital Assistants", "Address Books", "Language Translators", "Dictionaries", or any similar devices are prohibited. You may not bring books or other reference materials.

**OTHER INFORMATION FOR CANDIDATES:** The New York State Department of Civil Service has not prepared a test guide for this examination. However, candidates may find information contained in the publication "How to Take a Written Test" helpful in preparing for this test. This publication is available online at: <u>www.cs.ny.gov/testing/localtestguides.cfm</u>.

**<u>NOTE</u>**: Bring positive identification to the written examination such as a driver's license, passport or student identification which contains a photo and your signature. Candidates will not be admitted without the proper identification.

**<u>TIME AND PLACE OF EXAMINATION</u>**: Accepted candidates will be notified by letter when and where to appear for this examination. If notice of acceptance or disapproval is not received at least three days prior to the examination date, please call this office at (315) 366-2341.

The written test is being prepared and rated by the New York State Department of Civil Service in accordance with Section 23-2 of the Civil Service Law. The provisions of the New York State Civil Service Rules and Regulations dealing with the rating of examinations will apply to the written test.

**VETERAN'S CREDIT:** Veterans or disabled veterans who are eligible for additional credit must submit an application for veteran's credit with their application for examination or at any time between the dates of their application for examination and the date of the establishment of the resulting eligible list. <u>Applications</u> for veteran's credit are available from this office. Veteran's credit can only be added to a passing score on the examination.

Candidates currently in the armed forces may apply for and be conditionally granted veteran's credit in examinations. Any candidate who applies for such credit must provide proof of military status to receive the conditional credit. <u>No</u> credit may be granted after the establishment of the list. It is the responsibility of the candidate to provide appropriate documentary proof indicating that the service was in time of war, as defined in Section 85 of Civil Service Law, and that the candidate received an honorable discharge or was released under honorable conditions in order to be certified at a score including veteran's credit.
