- Applications must be received or postmarked by the application deadline. Carefully compare your qualifications against the minimum qualifications listed on the announcement and apply for only those examinations for which you clearly meet the required qualifications.

SALARY: \$20.00/hour (2025 Hire Rate)

<u>VACANCIES</u>: The eligible list established as a result of this examination will be used to fill present and future vacancies as they occur in the Madison County Soil and Water Conservation District.

RESIDENCY: There are no residency requirements for this examination. Preference in certification may be given to successful candidates who have been legal residents of Madison County for at least one month prior to the date of certification.

<u>MULTIPLE EXAMINATIONS SCHEDULED FOR THE SAME DAY</u>: If you have applied to take a written test announced by either one or several local jurisdictions (county, town, city) scheduled to be held on the same test date as this written test, you must notify each of the local jurisdictions no later than two weeks before the test date, so they can make arrangements for taking all tests at one test site. All examinations for positions in State government will be held at a State examination center.

<u>DISTINGUISHING FEATURES OF THE CLASS</u>: This is technical work involving the responsibility to perform technical activities related to conservation practices on private and public properties and water resources and for conducting field surveys, design and supervision of related conservation projects. Employees in this class are expected to be engaged in projects such as tree planting, planning and construction of farm ponds and soil and water management programs. The work is performed under the general supervision of the Board of Directors and under the direct supervision of the Conservation District Manager. The incumbent does related work as required.

MINIMUM QUALIFICATIONS: Either:

- A. Possession of a Bachelor's degree in environmental, mechanical or civil engineering technology, conservation or environmental technology, environmental control technology, environmental protection technology, agriculture or a closely related field; OR
- B. Possession of an Associate's degree in environmental, mechanical or civil engineering technology, conservation or environmental technology, environmental control technology, environmental protection technology, agriculture or a closely related field AND two (2) years of full-time paid experience, or its part-time and/or volunteer equivalent, in construction, land surveying, natural resource protection, landscaping, engineering, agriculture or related field; OR
- C. Graduation from high school or possession of a high school equivalency diploma AND four (4) full-time paid experience, or its part-time and/or volunteer equivalent, as listed in (B) above; OR
- D. An equivalent combination of training and experience as defined by the limits of (A), (B) and (C) above.

NOTE: Degree(s) must have been awarded by a college or university accredited by a regional, national or specialized agency recognized as an accrediting agency by the U.S. Department of Education/U.S. Secretary of Education. If your degree was awarded by an educational institution outside of the United States and its territories, the candidate must provide independent verification of equivalency. A list of acceptable companies who provide this service can be found on the internet at http://www.cs.ny.gov/jobseeker/degrees.cfm. Candidates will be required to pay the evaluation fee.

SPECIAL REQUIREMENT: Possession of the appropriate driver's license issued by the New York State Department of Motor Vehicles is required at the time of appointment.

SUBJECTS OF EXAMINATION: A written test designed to evaluate knowledge, skills and/or abilities in the following areas:

Collection, Analysis and Presentation of Data - These questions test for knowledge of the proper procedures and methods used to gather, evaluate, organize, and utilize various types of technical data and information, and the fundamental concepts, terminology, and computations involved in statistical analysis.

Principles and Practices of Soil and Water Conservation - These questions test for knowledge of the proper methods and techniques used to facilitate land and water conservation and may include such areas as: proper drainage and erosion control, soil types and watershed, stream and stream bank protection.

Construction and Maintenance of Soil and Water Conservation Projects - These questions test for knowledge of the methods, procedures and equipment used for building and maintaining conservation projects and may include such areas as: runoff diversions; farm ponds; stream protection and drainage and erosion control.

Resource Conservation Planning and Management - These questions test for knowledge of planning principles and practices in the soil and water conservation field and may include such areas as: interpreting topographic maps; erosion and sediment control and proper conservation tillage and land, project and construction management techniques.

<u>CALCULATOR</u>: Use of a hand-held, battery or solar powered calculator for this exam is <u>RECOMMENDED</u>. Cell phones and devices with typewriter keyboards, "Spell Checkers", "Personal Digital Assistants", "Address Books", "Language Translators", "Dictionaries", or any similar devices are prohibited. You may not bring books or other reference materials.

TEST GUIDE: The New York State Department of Civil Service has not prepared a test guide for this examination. However, candidates may find information in the publication 'General Guide to Written Tests' helpful in preparing for this test. This publication is available online at: https://www.cs.ny.gov/testing/testguides.cfm.

NOTE: Bring positive identification to the written examination such as a driver's license, passport or student identification which contains a photo and your signature. Candidates will not be admitted without the proper identification.

<u>TIME AND PLACE OF EXAMINATION</u>: Accepted candidates will be notified by letter when and where to appear for this examination. If notice of acceptance or disapproval is not received at least three days prior to the examination date, please call this office at (315) 366-2341.

The written test is being prepared and rated by the New York State Department of Civil Service in accordance with Section 23-2 of the Civil Service Law. The provisions of the New York State Civil Service Rules and Regulations dealing with the rating of examinations will apply to the written test.

<u>ADDITIONAL CREDIT</u>: In conformance with Section 85-a of the Civil Service Law, children of firefighters and police officers killed in the line of duty shall be entitled to receive an additional ten points in a competitive examination for original appointment in the same municipality in which his or her parent has served. If you are qualified to participate in this examination and are a child of a firefighter or police officer killed in the line of duty in this municipality, please inform this office of this matter when you submit your application for examination. A candidate claiming such credit has a minimum of two months from the application deadline to provide the necessary documentation to verify additional credit eligibility. However, no credit may be added after the eligible list has been established.

<u>VETERAN'S CREDIT</u>: Veterans or disabled veterans who are eligible for additional credit must submit an application for veteran's credit with their application for examination or at any time between the dates of their application for examination and the date of the establishment of the resulting eligible list. <u>Applications</u> for veteran's credit are available from this office. Veteran's credit can only be added to a passing score on the examination.

Candidates currently in the armed forces may apply for and be conditionally granted veteran's credit in examinations. Any candidate who applies for such credit must provide proof of military status to receive the conditional credit. No credit may be granted after the establishment of the list. It is the responsibility of the candidate to provide appropriate documentary proof indicating that the service was in time of war, as defined in Section 85 of Civil Service Law, and that the candidate received an honorable discharge or was released under honorable conditions in order to be certified at a score including veteran's credit.
